Graduate Institute of Photonics and Optoelectronics Regulations Governing Waiver of Credits for the Master's Program

- 一、擬抵免之科目需經指導教授同意。
- 1. Any course credit requirements which are to be waived must be first approved by the student's Thesis Adviser.
- 二、用來抵免之科目必須為研究所科目,且不計算在大學部畢業之最低學分數之 內,並檢附原就讀學校系所之應修畢業學分證明。
- 2. A course to be substituted for credit must be for a course at the graduate degree level or higher offered at a Graduate Institute, must not have already been counted towards credit for the minimum course credit requirements for the baccalaureate degree, and the original transcript and certification of prior academic study indicating major requirements shall be presented.
- 三、該科目成績須達等第成績 A(含)以上始得提出申請,並檢附該科成績單。
- 3. Courses presented for a waiver must have obtained a grade of A or above, and the official transcript of course grade notice shall be presented.
- 四、曾為外系所或外校之研究生最多可抵免9學分。
- 4. Former graduate students at other Graduate Institutes within this University or other universities, shall enjoy at most only nine credit hours to be waived by course substitution.

- 五、不曾為研究生者,最多可抵免大學部所曾修習課程6學分。
- 5. For students who have not formerly been graduate students, at most only six course credit hours to be waived by undergraduate course substitution.
- 六、外校學生擬抵免之科目,須至原就讀學校證明抵免之科目為研究所課程,並 檢附該抵免學分課程大綱。
- 6. Students from other institutions seeking course substitution waivers, must obtain certification from their original academic institution indicating the said course(s) were graduate level courses, and provide the syllabus and course requirements for the said substitution course.
- 七、以非本所認定之課程抵免本所認定之課程時,須經本所認定課程之授課教師 認可。
- 7. When waiver of a course is sought through substitution of a course not certified by this Institute, then approval of the faculty member offering the equivalent course sought to be waived at this Institute shall be obtained.
- 八、抵免學分申請案由本所課程委員會審查決議。
- 8. Applications for waiver of course credits through substitution shall be approved by this Graduate Institute's Curriculum Committee.
- 九、其他未盡事宜悉依本校規定辦理。
- 9. All other matters not covered herein shall be governed by the applicable regulations of this University.
