一、計點規則

I. Scoring regulations

(一)原則上,發表論文僅第一作者可獲得點數,然而經其指導教授同意,第 二作者亦可得計點,其點數為第一作者之點數的二分之一。

1. In principle, doctoral dissertation and academic paper presentation scoring points shall only be awarded to the first author, but where approved by the Dissertation Adviser, the second author also may enjoy point scoring, and their score shall be one-half of that awarded to the first author.

(二)所發表之論文至少需有一篇為第一作者。

2. Among the dissertation(s) or academic paper(s) presented, the candidate shall be the first author for at least one thereof.

(三)計算發表順位時,指導教授是否列入,由指導教授決定。

3. When determining the respective author positions, whether the Dissertation Adviser shall be included therein, shall be determined by the Dissertation Adviser.

(四)合格標準:總點數必須超過4點(含4點)。

4. Standard for approval: when the total points surpass 4 (and including 4).

(五)發表之論文,若學位論文指導教授非共同作者且未經學位論文指導教授 與原發表論文指導教授簽署同意者,則不予計點。

5. For dissertation(s) and academic paper(s) presented, where the Dissertation Adviser is not a joint author and the dissertation has not been signed by the Dissertation Adviser and original paper Adviser, then no score shall be permitted. (六)發表之論文,未註明台灣大學光電所為發表單位者,不予計點。

6. For dissertation(s) presented, where the Graduate Institute of Photonics and Optoelectronics, National Taiwan University, is not listed as the publisher or institutional affiliation, then no score shall be permitted.

(七)研討會所發表之論文,不予計點。

7. For academic papers published at academic conferences, no score shall be permitted.

二、確實點數需經所方仔細認定。

II. All scores shall be confirmed in detail by the Graduate Institute.

三、論文計點標準另表明列。未明列之期刊,其點數由學術委員會審定。

III. The dissertation scoring standards shall be elsewhere published in detail. For journals not listed with a score, the relevant scoring shall be determined by the Academic Committee.
